

 - Paper reports mailed to systems in September from Measured Progress—separate shipments
 - Online with passwords
 - ACT individual reports sent to students & schools 3-8 weeks after testing date
 - District Profile Report & District Student Level Data File mailed to STC no later than August 22.
 - MSAA (Multi State Alternate Assessment)
 - Online with passwords. Schools print parent reports: Aug.18-Sept.19
