

## College and University Websites

If you have a student who wishes to pursue college after high school it is important to remember all the colleges and universities require different documentation when requesting accommodations for disabilities. Make sure to assist the student in contacting the college or university ahead of time to make sure they have all proper documentation. Some institutions may require an evaluation which has been conducted within the last 18 months. Please keep in mind this IS NOT done for the institution, but for postsecondary goals and transition planning. This is an acceptable reason for re-evaluation and may be necessary depending on the student. This would be considered a part of that student's postsecondary planning needed to be looked at on a student-by-student basis. You may want to reach out to the Disability Services Coordinator at the college or university the student wishes to attend to see if they would be willing to sit in on the student's last IEP to provide input in preparing the student for college admissions.
